Funds for Continued Violin Upkeep and Protection

As my four years at UVA have progressed, I have become more and more involved in the music department and increasingly serious about violin performance. With the help of the Miller Arts Scholars program, I have been able to receive necessary funding to keep up with my increased involvement. Most recently, I was accepted to the Music Department's Distinguished Majors Project (DMP) program for exceptional 4th-year music students. Through this program, I am preparing to give a recital in March of 2022 of all-Hungarian music, which reflects the repertoire that I have been studying over the past few years. In order to help me best prepare for this recital, I am requesting a Miller Arts Artist Minigrant to cover the cost of new sheet music for the recital and a new instrument case for my violin. These resources will help me prepare for my upcoming DMP recital and other performances so that I am able to reach my highest potential during my last year of study while at UVA.

Preparing an all-Hungarian recital comes with a variety of challenges. Most obviously, many of the prominent Hungarian composers such as Bartók and Kodály were pushing the limits of compositional technique, resulting in pieces that are extremely challenging to learn and perform. But another surprising challenge for this recital is that not much of the music is actually available at the UVA Music Library, which I normally take advantage of due to its incredibly extensive collection. The Dohnanyi Sonata I am learning for the recital is not available at the library, and the edition of the Bartok Second Violin Sonata that I am learning is in very poor condition. Therefore, I am asking for funding to purchase new editions of these two pieces, so that I am not hindered by lack of accessibility to necessary sheet music when learning the music on my own and rehearsing together with piano. An additional challenge is that much of this music is only available internationally and is not actually published in the US, so the additional fee for shipping makes it more challenging for me to afford.

I am also requesting funding for a new violin case. I have had my current case for a number of years, and as seen by the images below, the case is significantly scratched and the edges of the case are warped. In addition, the latches are not super sturdy and this means there is a risk of the case opening unintentionally while traveling. To keep up with the increased amount of travel I have been doing in college to various gigs as well as traveling home to Connecticut, I am in need of a case that can withstand more wear-and-tear than my current case. Since I travel home regularly from school, I need a case that is easy to transport and lightweight but also sturdy enough to last for a long time. Lightweight, sturdy cases are challenging to engineer and are therefore more expensive than the average violin case. Receiving funding for this new case would quell my anxiety regarding the lack of safety with my current case, and would also help me afford a case that meets my needs.

Thank you for taking the time to read and consider my request. Any aid in the funding of the purchase of these resources would be greatly appreciated and would allow me to feel more comfortable with future performances and other violin-related endeavors.
